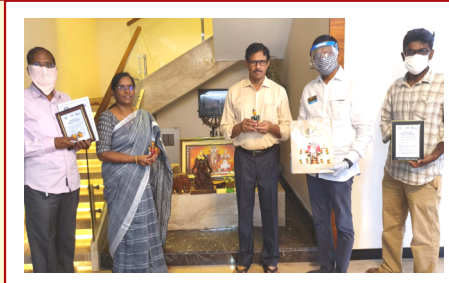


## ANNIVERSARY WISHES
